

# Privacy Policy

Personal Data Administrator.

The data administrator is P.P.H.U. „Inter-Styl” Róża Rusnak, contact with the Administrator is possible by e-mail: [noclegi.interstyl@gmail.com](mailto:noclegi.interstyl@gmail.com)

Processed data.

1. The Administrator obtains information about users in the following manner:

1. during contact between users and employees of P.P.H.U. „Inter-Styl” Róża Rusnak by e-mail or telephone, voluntarily providing their data (name, surname, telephone number, e-mail address)
2. by entering data by users in the contact form available in the Contact tab
3. by saving cookie files (so-called "cookies") in end devices

1. The user's personal data are processed, to the extent that the user has consented to this, in order to:

1. respond to the user's application submitted via the Form, by e-mail or telephone,
2. conclude an agreement between the user and P.P.H.U. „Inter-Styl” Róża Rusnak,

Transfer of data to third parties.

1. Users' personal data may be transferred to entities authorized to receive such data under applicable law, including the relevant judicial authorities.
2. Users' personal data may be transferred, to the extent necessary, for a specified period, to third parties acting on behalf of the Administrator in order to implement the Agreement with the user.

User Rights.

1. Users' personal data will be stored for the period necessary to achieve the processing purposes described above, and after the completion of these purposes, they will be stored by the Administrator until the obligations provided for by law and requiring the processing of the user's personal data are fulfilled.
2. Users' personal data are processed by the Administrator in accordance with the law. The legal basis for the processing of the user's personal data is the user's consent and/or the relevant provision of generally applicable law.
3. The user has the right to request from the Administrator access to their personal data, their rectification, transfer and deletion, as well as the right to limit the processing of personal data and the right to object to the processing of personal data.
4. The user may withdraw consent to the processing of data at any time by submitting a statement to the e-mail address: [noclegi.interstyl@gmail.com](mailto:noclegi.interstyl@gmail.com)
5. In the event of failure to express consent or limiting it to data processing by the user, the Administrator reserves the right to refuse to provide services that, if performed for the user without consent to the processing of data, would violate the law.

Information about cookies

1. The website [www.noclegiinterstyl.pl](http://www.noclegiinterstyl.pl) uses cookies.
2. Cookies (so-called "cookies") are computer data, in particular text files, which are stored on the end device of the website user (for a period of up to 1 month) and are used for the convenience of using the website.
3. The entity that places cookies on the end device of the website user and obtains access to them is the company P.P.H.U. Inter-Styl Janusz Rusnak
4. Cookies are used to create sessions.
5. Internet browsers usually allow cookies to be stored on the end device of the user by default. It is possible to delete cookies or change the settings so that cookies are automatically blocked. Such actions are the responsibility of the user.
